前言：

英国短期学生签证逻辑简单，主要是为了提供材料证明以下三点：

- (1) 证明是自己本人，且有正当理由去英国；
- (2) 抵达英国之后有足够的资金可以支持在英国停留时间的花费；
- (3) 保证会按时回来，不会非法滞留。

## 赴英学生短期访问签证准备指南

### 一、准备签证材料

前言：

英国短期学生签证逻辑简单，主要是为了提供材料证明以下三点：

- (1) 证明是自己本人，且有正当理由去英国；
- (2) 抵达英国之后有足够的资金可以支持在英国停留时间的花费；
- (3) 保证会按时回来，不会非法滞留。

### 学生短期访英签证材料明细（文档后面附有材料中英文模板）

注意：

- 按实际情况准备材料，每个人的材料和模板都会有些不一样；
- 要求签字的地方，签署中文汉字即可。
- 所有材料，英国签证中心并不扣留，只是送到签证官那里审批需要。签证审批完以后，会和护照一起寄给本人。

**1. 护照原件和复印件** (须有 6 个月以上有效期，至少一页空白页)

如有旧护照也须提供；如旧护照被签发机关回收，请忽略此条信息。

- 文档下面有样本，最好是学校抬头纸打印。须证明学生是在校生，包含学生的基本信息、也可以写上往返英国时间和目的，并签字盖学校公章 **或** 院系 **或** 教务处 公章并签字。
- 每个学校在读证明版本不同，以本校版本为准；
- 一定要盖章。

**3. 户籍证明**

户口簿全本复印件或集体户口个人页复印件；

**4. 与出资人关系证明：**

**情况一：**若本人户口与父/母/父母（出资人）户口在一个户口本上，则需准备户口本全本复印件；单亲只开自己户口所在一方的证明；

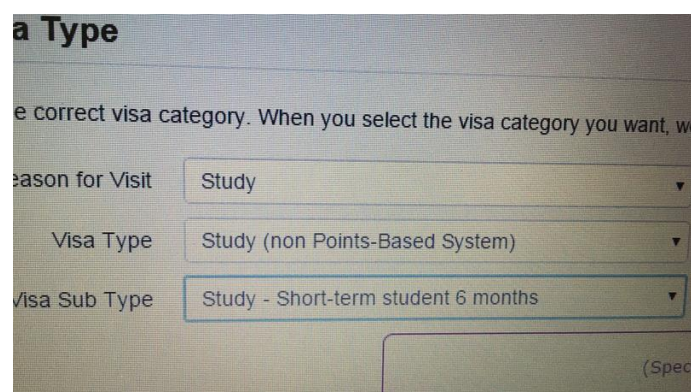
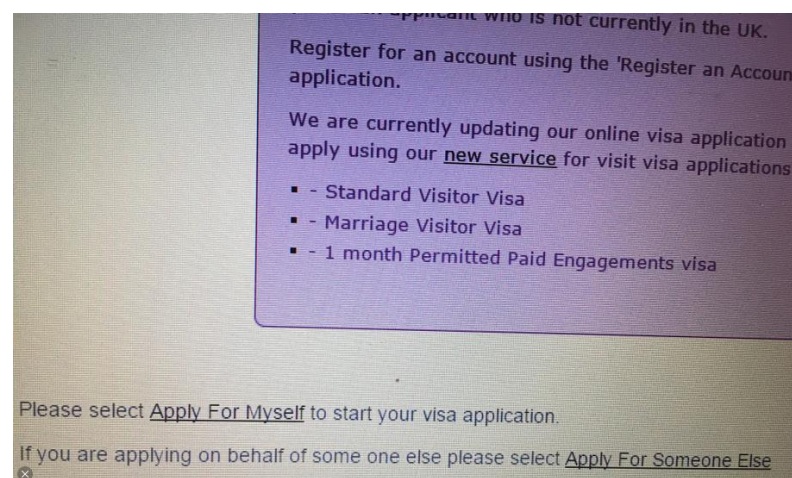

按照系统显示, 一步一步来填就可以了。填完并付费后, 打印 2 份材料 (**Appointment Confirmation** 预约确认单+ **Application** 申请材料单), 签字的地方有两处。签好之后和准备的签证材料按照预约的时间, 拿到英国签证中心递交。

- 英国的居住和联系地址填写(按照邀请函上的学院地址填写): XXX College, University of Oxford, XXX Street, Oxford, OX1 3XX(邮编), United Kingdom  
Line 1/Line 2/Line3/Line4: 这些地名一般要从小到大排列.如: Line1: XX College (最具体的地名), Line 2: XX Street (街道名称), Line 3: Oxford (城市名); Line 4: United Kingdom (国家名)。由小到大填好就行, 并不拘泥于形式。

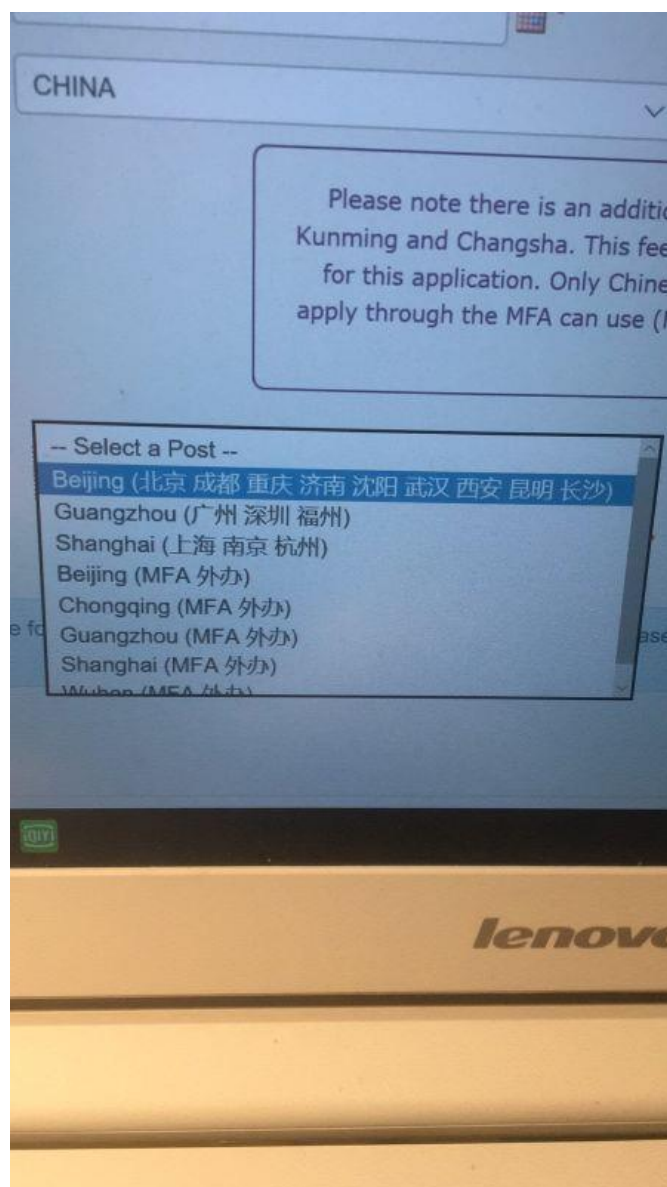
几个 tips:

- ① 护照签发机构写全称写不开, 可以写简写 “MPS EXIT ENTRY ADMIN”;

- ② 在最终提交表格、缴费之前，需要把材料准备齐，最起码存款证明要开出来。就是说，你在 7 月 3 号 Submit 了表格，并付费了，那么最晚 7 月 2 号就得把存款证明办好；
- ③ 最终的申请表的 pdf 生产出来会有一定的延迟。付款成功之后，点击 “view my application” 可能会显示 “Your application is being processed”，不用担心，过一段时间之后就能生成 pdf 了，耐心等待就好。如果 pdf 生成了会有邮件提醒的；
- ④ 一次填写不完，可以点击左边的 Save，以后再填。当然，save 之后还是尽快填完，因为只有一定的保存期限（一个月左右）；

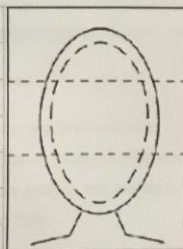
